2. Consigned Books: The Author agrees to consign the following books to Love Stories:

**3. Term of Agreement:** This Agreement shall begin on the date above and will continue for a period of 6 months unless terminated earlier in accordance with the terms outlined in Section 8.

# 4. Sales and Payment:

- The Store agrees to sell the consigned books on behalf of the Author.
- The Author shall receive 60% of the retail price for each book sold.
  - If a credit or debit card is used for purchase, a 1.5% fee will be deducted.
- Payments to the Author will be made on a monthly basis, by the 15th day of the following month, for all books sold in the previous month. Payments will be made via check.

# 5. Pricing:

- The retail price of the consigned books will be set by the Author, as indicated in the table in Section 2.
- The Store reserves the right to discount the books, with the Author's prior written consent, for promotional events or sales.

## 6. Delivery and Risk of Loss:

- The Author is responsible for delivering the books to the Store at their own expense.
- Risk of loss or damage to the consigned books shall remain with the Author until the Store takes physical possession of the books.
- The Store will take reasonable care of the consigned books while they are in its possession.

### 7. Unsold Books:

- The Store will notify the Author of any unsold books at the end of the consignment period.
- The Author must arrange for the collection of unsold books within 15 days of notification. If the books are not collected within this period, the Store may dispose of the books at its discretion.
- Contract term can be extended if both parties consent.

### 8. Termination:

- Either party may terminate this Agreement at any time by providing 30 days' written notice to the other party.
- Upon termination, the Author must collect any unsold books within 15 days, as outlined in Section 7.
- **9. Author's Warranties:** The Author represents and warrants that they are the sole owner of the consigned books and have the right to enter into this Agreement. The books do not infringe on any copyright, trademark, or other rights of any third party.
- **10. Indemnity:** The Author agrees to indemnify and hold harmless the Store from any and all claims, damages, liabilities, costs, and expenses arising out of or related to the sale of the consigned books, including but not limited to any claims of infringement.
- **11. Governing Law:** This Agreement shall be governed by and construed in accordance with the laws of the State of [Insert State], without regard to its conflict of law principles.
